The final condition for e-signatures to be used under HIPAA rules relates to copies of signed documents residing on the servers of e-signature service providers. For a covered entity to ensure the integrity of PHI, all the evidence supporting the e-signature should be on the same document under the ownership and control of the covered entity.
