By default, Twitter will attempt to notify the reported account holder (s) of the existence of a legal request pertaining to the account (s) if we are not otherwise prohibited from doing so. Exceptions to user notice may include exigent circumstances, such as emergencies regarding imminent threats to life, child sexual exploitation, or terrorism. Twitter attempts to notify the user (s) about the legal request through a notification in the Twitter app and by sending a message to the email ...

Twitter receives requests for account information from non-governmental parties around the world. These typically include civil actions, such as a divorce proceeding, as well as requests made by criminal defendants, where they are typically seeking account information in support of their legal defense.
